## **UNIFORM SALES & USE TAX EXEMPTION/RESALE CERTIFICATE**

The State of Arizona, the counties, and the local municipalities impose Transaction Privilege Tax (TPT), commonly referred to as "sales tax", on the gross income of certain persons/entities for the privilege of conducting business within an Arizona jurisdiction.. Although this tax is generally passed to the consumer, ultimately it is the liability of the person/entity conducting the business.

1. Registered sellers who accept fully completed exemption certificates within 90 days subsequent to the date of sale are relieved of liability for the collection and payment of sales tax on the transactions covered by the exemption certificate.

## **Audit Evidence - AICPA**

A sales tax is a tax paid to a governing body for the sales of certain goods and services. Usually laws allow the seller to collect

funds for the tax from the consumer at the point of purchase. When a tax on goods or services is paid to a governing body directly by a consumer, it is usually called a use tax. Often laws provide for the exemption of certain goods or services from sales and use tax.
